- 3 We do NOT charge clients for our services

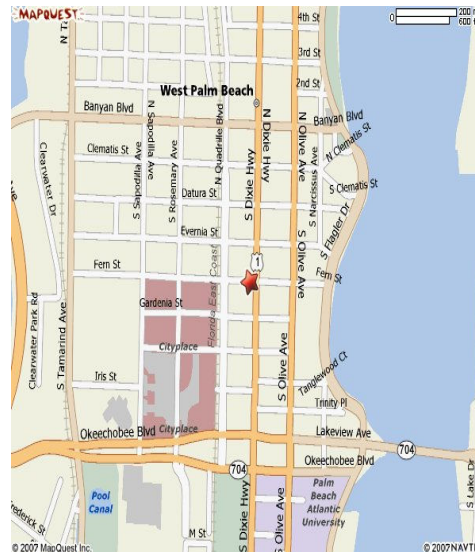


## WHERE TO FIND US

## CONFLICT RESOLUTION ELIGIBILITY REQUIREMENTS

The Legal Aid Society of Palm Beach County's **Low Income Taxpayer Clinic** may represent taxpayers who meet the following criteria:

1. **Income ceiling** less than 250% of the poverty guidelines published annually by the HHS (Effective January 2024)

Size of Family Unit	Family Income May Not Exceed:
1	\$37,650
2	\$51,100
3	\$64,550
4	\$78,000
5*	\$91,450

\* add \$13,450 for each family member in excess of 5

2. **Amount in controversy** generally may not exceed the amount specified in IRS Section 7463 (currently \$50,000)



## HOW THE LITC CAN HELP YOU

The Legal Aid Society of Palm Beach County's **Low Income Taxpayer Clinic** may help if you have a disagreement with the IRS. The LITC provides controversy assistance to income-eligible taxpayers in Palm Beach County.

- We assist taxpayers who have received a Notice of Levy or Notice of Filing of Federal Tax Lien.
- We represent taxpayers who are being audited by the Internal Revenue Service Examination function in connection with their individual or employment tax liabilities.
- We assist taxpayers with their Earned Income Tax Credit filings, audits and appeals.

The Legal Aid Society's **Low Income Taxpayer Clinic** maintains strict confidentiality with its clients. Taxpayers should be prepared to answer questions regarding income, citizenship status, employment status and other relevant issues that may affect your tax issue. The more information you can provide, the better we can serve you.

## HELPFUL HINTS FOR USING THE LOW INCOME TAXPAYER CLINIC

It is helpful to have the following items available prior to your call or visit requesting help:

- Current income records such as pay stubs or receipts;
- All letters, notices, bills or correspondence from the IRS;
- A copy of ALL letters you wrote to the IRS;
- Copy of tax returns in controversy;
- Copies of all tax returns filed in the past 5 years;
- Any other papers that pertain to your tax disagreement.

## OTHER LEGAL AID SOCIETY SERVICES

In addition to the **Low-Income Taxpayer Clinic**, the Legal Aid Society of Palm Beach County provides free legal advice, representation and education in areas such as foreclosure defense and prevention, family law issues, domestic violence advocacy and Social Security and Medicare assistance (for individuals over 60 years of age).
